

# THT HEALTHCARE GOVERNANCE CONFERENCE SPONSOR CONTRACT TERMS AND CONDITIONS

- 1. Complimentary Registrations: Sponsoring/exhibiting company (ies) may qualify for a designated number of complimentary conference registrations. Due to capacity restrictions, THT cannot guarantee access to meal functions or in-person education sessions. THT reserves the right to permit sponsors access to any conference event, educational session, or meal function. The number of complimentary registrations by sponsorship/exhibit option will be designated in the respective sponsor prospectus.
- 2. Exhibit Space: Levels that include a physical display area receive a 6' skirted table with two chairs. Additional exhibitor services, such as electricity, are available through the hotel/ conference venue for an additional charge.
- 3. Sponsor Recognition: To be recognized in the on-site conference program and conference signage, sponsor contract must be received and accepted by THT with full payment by May 16, 2025. Any contracts received and accepted after May 16, 2025 must include full payment.
- 4. Attendee List: Sponsors/exhibitors will receive a list of registrants prior to the event and list of attendees after the event (per THT privacy policy, attendee emails and personal phone numbers are not provided).
- 5. Website Listings: All sponsors/exhibitors will be listed on the conference pages of the THT website and linked to the sponsor/ exhibitor's website URL specified on the sponsor/exhibitor application form.
- 6. Contributions: All sponsor/exhibitor contributions are voluntary. Sponsorships/exhibits are accepted on a first-come, first-serve basis, based on date and time of the receipt of contract. THT reserves the right to limit the number of program sponsors/exhibitors and may reject any sponsorship/exhibit for any reason. THT reserves the right to refuse any sponsor/exhibitor that conflicts with the sponsorship/exhibit public policies or applicable law. Fees collected prior to such refusal shall be returned to the sponsor/exhibitor within 45 days.
- 7. Conduct of Exhibitors: The purpose of the event is to educate persons employed and who volunteer in the health care field in the utilization and development of new products, equipment and/or services. This does not preclude the stimulation by sponsors/ exhibitors of interest in and demand for such products and/or services on the exhibit floor. All business activities of the sponsor/exhibitor must be within the sponsor/exhibitor's allocated exhibit space. In keeping with the nature of a health care professional meeting, undignified promotional methods and/or materials considered to be objectionable by the association are expressly prohibited. If food products are permitted to be served, the preparation of such foods cannot cause odors considered to be offensive or objectionable to other sponsors/ exhibitors or registrants, and must follow applicable guidelines. In no event shall foodstuffs or beverages of any kind be served in individual servings larger than a bite-sized sample of food or four ounces of liquid, respectively. Private social functions hosted by sponsors/exhibitors must be scheduled at a time or place where they will not conflict with official conference activities scheduled by the association, and must comply with any applicable guidelines or restrictions.

8. Cancellation: All sponsor cancellations must be submitted to THT exhibits management in writing. Cancellations received by THT on or before May 1, 2025 will be assessed a fee of 50 percent of the total sponsorship cost. No refunds will be given on cancellations received after this date. Notwithstanding any provisions to the contrary herein contained, Texas Healthcare Trustees shall not be liable for any delay or inability to perform any obligation under this agreement resulting from governmental emergency orders, judicial or governmental action, sabotage, riots, vandalism, labor strikes or disputes, acts of God, pandemic, fires, electrical failure, major computer hardware or software failures, acts of third parties, or any other cause, if such delay or inability to perform is beyond its reasonable control.

Golf Weather Cancellation. We follow the guidelines outlined by the golf course. If the course is open, then events are expected to play. If lightening is present, play will be delayed or suspended. An event may be delayed or suspended due to inclement weather. Additional limitations may be placed on golf car access to fairways. If canceled on the day of, prior to start of the tournament, sponsors will receive a 50%. If canceled part way through play, sponsors will not receive a refund.

- 9. Rules and Regulations: Corporate members and sponsors represent and warrant that they:
  - a) Have sufficient resources and capacity to provide the products and services that are being promoted under this agreement.
  - b) Maintain all licenses and permits required by law, and are the rightful owner and licensee of all products and services that are being promoted under this agreement.
  - c) Have never been the subject of a lawsuit or governmental investigation or action and are not now subject to any threatened or existing claim, lawsuit, or governmental investigation, inquiry or
  - d) Have never been excluded, suspended, barred from participation in or subject to penalties from any governmental program (including but not limited to the Medicare or Medicaid program).
  - e) Will comply with state, local and federal requirements related to health and safety or enacted as a precaution against the transmission of COVID-19.
  - f) Any sponsors that tears down their exhibit space prior to the designated time will be charged a \$1500 fee for early departure and disruption of the conference.
  - g) THT will honor a badge swap for companies that would like to send different attendees on different days for a fee of \$500 per change. We will not honor more attendees on site than provided by sponsorship level. This exchange must be coordinated with THT in advance of the conference.
